CITY OF TURLOCK:

At a meeting held on October 8, 2024, the City of Turlock approved to increase its wastewater discharge rates to industrial customers beginning January 2025. We will need to confer with District Counsel for direction on rate study.

- B. Evan Licht & Ralph Holmes, LGI Homes and Mike Whipple, Development & Financial Advisory California Municipal Finance Authority (CMFA) Bond Opportunities for Land Development (BOLD Program).

The BOLD Program is a financing program offered by the California Municipal Financing Authority (CMFA) to allow financing of public infrastructure and impact fees for development projects. Under the BOLD Program, Community Facility Districts will be created by the CMFA to finance eligible improvements and local agency fees.

Denair CSD will be required to join the CMFA by adopting a resolution. A public hearing will be held for the citizens of Denair at a later date prior to adopting a resolution to join the CMFA.
